Notice is hereby given to all interested members of the public that the Board of Directors (“Board”) of the above captioned District will hold a regular meeting, open to the public. In light of the recent pandemic and national/local emergency declarations, and in conjunction with the most recent executive action by Texas Governor Abbott regarding the Texas Open Meetings Act, additional notice is hereby given that this meeting will be held via videoconference (\*\**please see below and/or the District website [www.westwoodmpid.org](http://www.westwoodmpid.org) for further details*). The meeting will be held on **Friday, April 9, 2021, at 12:00 p.m.**, to discuss and, if appropriate, act upon the following:
